Annual Report of Karnataka Employers' Association for the year 2019-2020 presented at the 59th Annual General Meeting held at 11.30 am on Thursday, 23rd July 2020, through Virtual Platform

Karnataka Employers' Association (KEA) established in the year 1961 has stepped into its 59th years of service to our Members. On the occasion of the 59th AGM the Working Report for the year 2019-2020 (from 1st April 2019 to 31st March 2020) of Association is presented to members. This report gives an overall view of the activities of the Association during the year 2019-2020.

1. KEA Circular Service:

The Association has issued 100 circulars during the Calendar year 2019 (Previous Calendar Year – 2018 – 95 Circulars) and has been keeping the members informed on the latest developments in the matters pertaining to Labour & Employment Legislation, Industrial Relations, Wage Agreements and other related areas. Our circular services continue to be appreciated and sought after for information by the members. Incidentally, we have issued 134 Circulars during the period 1st January 2020 to July 2020 out of which 89 Circulars have been issued during four months starting from 1st April 2020 to July 2020 until now. (Covid 19 period).

The Financial position of the Association has been reasonably well thanks to the prudent financial management practices followed by KEA. The audited balance sheet for the year 2019-20 has already been circulated to the members.

Daily News update

During the month of September 2015 KEA started new system of information updating called "*Daily News Update*" by extracting important clippings from daily news and presenting the Labour & Employment related news in a short and concise manner. This initiative has been appreciated by all the members. The same is continued.

2. Membership:

The total membership of the Association stood at 780 as on 31st March 2020, which is inclusive of 57 new members admitted during the year 2019-2020.
