Under the EPF Act the principal employer is required to ensure that the employees engaged through the contractor by the establishments covered under the EPF Act, fully comply with the provisions of the Act and remit the contribution in respect of the employees engaged by the contractor, regularly and promptly within the prescribed time.

The EPF Organization as a part of E-Governance initiatives have developed "EPFO Principal Employer portal" on which principal employers awarding contract can register the details of their contractor which is reflected in the domain of the concerned regional office of the EPFO.

Enclosed is the copy of the Internal Circular dated: 27.6.2017 issued by the EPF Organization to their field functionaries to verify the details of the contractor loaded by the Principal Employer on the above portal. The members may ensure that complete and correct details of the contractors are uploaded on the Principal Employer portal.
