The BESCOM held a cocoordinating meeting between its officers and KASSIA & FKCCI representatives on 15.10.2015 to address the present power crisis. After detailed discussion have finalized the implementation of staggering of holidays (shifting of holiday from Sunday to a week day) for industries in BESCOM jurisdiction has one of the load management measures and decided to implement area wise staggering of holidays for industries as detailed below.
