GOVERNMENT OF INDIA DECLARES A HOLIDAY ON 14-04-2023 BIRTHDAY OF DR.B.R. AMBEDKAR AND APPLICABLE TO GOVT. OFFICES, BANKS AND GOVT. INDUSTRIAL ESTABLISHMENTS

1. The Government of India has issued a Gazette Notification No. F.No.12/4/2020.JCA dated 11-04-2023 declaring Friday, 14-04-2023 as a closed holiday on account of the Birthday of Dr. B. R. Ambedkar for all Central Government Offices including Industrial Establishment throughout India by invoking the powers under Section 25 of the Negotiable Instruments Act 1881.
2. The above gazette notification of Government of India issued under Negotiable Instruments Act will be applicable only to Government offices, Banks and Industrial Establishments run by any department of Government of India. Therefore, the word 'Industrial Establishment' referred to in the gazette notification dated 11-04-2023 of Government of India should be read to mean that it would be applicable to Industrial Establishment or Factory or Office directly operated by any department of the Government of India. For example, Ordnance Factories are directly established and run by the Ministry of Defence. Therefore, the notification issued under the Negotiable Instruments Act will be applicable to such industrial establishments.



3. Accordingly, the gazette notification issued by the Central Government dated 11-04-2023 is not applicable to the Industrial Establishments in Private Sector. Hence, the member establishments in Private Sector are not required to declare paid holiday on 14-04-2023 on account of the Birthday of Dr. B. R. Ambedkar.
