FORMAT OF JOINT DECLARATION FOR CLAIMING HIGHER PENSION

- 1. KEA has circulated the draft of the notice to be displayed on the notice board of the Establishment to enable the existing employees as well as the pensioners to claim higher pension on the basis of the judgement of the Supreme Court in the case of EPFO Vs. Sunil Kumar.B decided on 04.11.2022 vide Circular No. 30/2023 dated 22.02.2023.
- The gist of the interim order dated 12.04.2023 passed by the Hon'ble High Court of Kerala in W.P.No. (C) No.8979/2023 and other connected 13 writ petitions was circulated to the members vide KEA Circular No. 48/2023 dated 13.04.2023.
- 3. The Association having regard to the interim order passed by the Hon'ble High Court of Kerala has devised format of joint declaration to be submitted to the EPFO by the serving employees as also those employees who are retired from the service. Revised formats are attached as Annexure-A & B respectively.
- 4. The application may be uploaded on the online mode. If for any reason, the application cannot be uploaded on the portal of the EPFO, the establishment may have the applications delivered at the office of







the concerned RPFC and acknowledgment may be obtained and preserved. If the same cannot be done for any reason, the application along with all the annexures be sent by RPAD and the postal acknowledgement may be preserved. If postal acknowledgment is not received, the establishment may download the postal tracking of the documents and preserved.

5. The entire process be completed before 03.05.2023 the last date specified by the EPFO for claiming higher pension in terms of the judgment of the Supreme Court.
