# EPFO EASES THE PROCEDURE FOR WITHDRAWING FROM PROVIDENT FUND TOWARDS ADDITION OR ALTERATION ETC OF DWELLING HOUSE

1. The Provident Fund Scheme permits the members to withdraw from the provident fund towards additions, substantial alteration or improvement necessary to the dwelling house owned by the member or by the spouse or jointly by the member and the spouse. The said sub-para provides as under:

"An additional withdrawal up to twelve months basic wages and dearness allowance or the members own share of contributions with interest thereon, in the amount standing to his credit in the fund, whichever is less, may be granted in one instalment only, for additions, substantial alternations or improvements necessary to the dwelling house owned by the member or by the spouse or jointly by the member and the spouse.

Provided that the withdrawal shall be admissible only after a period of five years from the date of completion of the dwelling house."

2. EPFO Head Office by their circular dated 17.04.2025 have eased the procedure for applying for withdrawal from the provident fund for the purpose referred to above and laid down that the members to avail advance under para 68-B(7) may apply based on self declaration that the advance is claimed only after 60 months from the date of completion of the dwelling


