CHANGE OF DESIGNATED LABOUR COURTS UNDER ID ACT

The Government of Karnataka in exercise of power conferred by sub-section (1) of Section 7 of the Industrial Disputes Act 1947 and in partial modification of the earlier notification in this behalf, in consultation with the Hon'ble High Court of Karnataka has changed the designated Labour Courts as under;

- i. The II Addl. Labour Court, Bengaluru as the Labour Court, Bengaluru for Bengaluru Rural District.
- ii. The Principal Labour Court, Bengaluru as labour Court for Ramanagara District until a Labour Court at Ramanagara is established by the Government.

The above change shall come in to force from 8.6.2025. Copy of the Government Notification dated: 8.6.2025 is enclosed.

In terms of the above notification all the cases pending before the Principal District and Sessions Judge Rural District, Bengaluru will stand transferred to Second Addl. Labour Court, Bengaluru.





All the cases Pending before the Principal District Judge and Session Judge, Ramanagara will stand transferred to Principal Labour Court, Bengaluru until Labour Court at Ramanagara is established by the Government.

NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 7 of the Industrial Disputes Act, 1947 (Central Act 14 of 1947) and in partial modification of the Notifications issued earlier in this behalf, the Government of Karnataka in consultation with the High Court of Karnataka hereby designate;
